- a. **DPI Mental Health Grant Award** Mr. Waukau shared the great news of this grant award. The \$75,000 funding will cover the counselor at Keshena Primary School. This posting closes Friday, however, interviews have already started as applicants are applying.
- b. Youth Mental Health First Aid (YMHFA) Train the Trainers Mr. Waukau shared additional good news about this training. The district was awarded 3 free slots to this training, which is 40 hours of training. The following staff are currently attending: Michelle Frechette, Sarah Lamia, and Natalie Minshell. Following this training, they will start training in the community.
- c. **MISD Strategic Alignment Planning 2018-19** Mr. Waukau shared information about the process of MISD Strategic Alignment Planning. He will share additional information when its completed.
- d. **On-line Registration Update** Mr. Waukau shared the numbers of registrations so far from parents for the new school year. This is a huge jump for MISD, so far there are 96 KPS registrations, 28 started, 25 4K signed up. MIMS has 24 registrations with 6 started; MIHS has 30 registrations.
