The Menominee Indian School District has a part-time Bus Monitor position available, which includes both the A.M. and P.M. shifts. Shift hours are 6:00 a.m. to approximately 8:15 a.m. and 2:30 p.m. to approximately 5:30 p.m. Monday through Friday.

QUALIFICATIONS:

Candidate shall possess a high school diploma or is equivalent, CPR/First Aid Certification desired.

RESPONSIBILITIES:

To assist in providing safe transportation for district students.

ESSENTIAL JOB FUNCTIONS:

Works cooperatively with assigned bus driver; assists young and disabled students in getting on and off bus and assures that students get on and off the bus in an orderly fashion; observes all mandatory safety regulations and enforces all bus regulations; assist in bus drills; develops all conduct reports whether monitor or driver generated and turns them into the appropriate personnel; provides sufficient supervision to prevent behavior problems and vandalism on the bus; provides appropriate safety measure and supervision for students; communicates expectations regarding student behavior to students and parents; keeps the principal/s informed regarding behavioral situations that may warrant his/her attention; perform other duties as may be assigned by immediate supervisor.
